



PROJECT AREA




City of Fresno + Top 5% Disadvantaged Communities, CalEnviroScreen 3.0

City of Fresno + Top 5% DACs + Recent Specific and Community Plans + HSR Station Area




Southwest Specific Plan (anticipated adoption October 2017)

- Materials Management
- Climate Resiliency

- High Quality Job Creation and Local Economic Development

What can be funded with State TCC:
