TRANSFORM FRESNO CODE OF CONDUCT

The Transform Fresno Outreach and Oversight Committee, in order to aid in the strengthening of our community through the Transform Fresno Project, assembled the following code of conduct. In their deliberations, the Committee recognized...

1. That while all neighborhoods are not equal, it is important to be equally mindful of each neighborhood's unique needs and that we are unified as neighborhoods;
2. The importance of looking at our neighborhoods and our City through the lens of our assets;
3. The goal of Transform Fresno: to see every project successfully completed, adding to the transformation of our Downtown, Chinatown and Southwest Fresno neighborhoods and our City as a whole.

Eight Core Rules for Crucial Conversations & Community Meetings¹

• **PRACTICE RESPECTFUL LISTENING** – Truly listen to what people are saying rather than using that time to think about what you want to say when they are finished. Please also refrain from engaging in side-bar conversations.

• **PRACTICE RESPECTFUL TALKING** – This is about being concise in your statements, not talking over other people, not engaging in sidebar conversations, and not dominating the conversation. It may be helpful to think of the acronym WAIT – Why Am I Talking?

• **MAKE “I” STATEMENTS INSTEAD OF “YOU/US/THEY” STATEMENTS** – This is about not attributing things that you say to other people—owning your thoughts, feelings, and actions. Come from a place “I think/I believe/I feel” rather than “you think/you believe/ you feel.”

• **REMEMBER THE PRINCIPLES OF GRATITUDE & INVITATION** – We are all grateful to be at the table with one another and to spend this time together, to engage in this work, and learn from each other, so let's demonstrate that in the way we communicate and treat one another.

• **BE PRESENT** – We know that the world and our inboxes continue outside of this room. So much of what you will learn today will be from one another, so please do your best to be physically and mentally present today. This means being especially mindful of the use of our mobile devices.

• **CONFIDENTIALITY** – People may share information that is personal to them. We ask that everyone agree that nothing personal discussed in this room will be shared outside of the room in order to make this this is a safe space for discussion and learning.

• **BE HONEST**– We aren't concerned that you will lie! The value of the conversation is determined by how engaged we are in the discussion, so please be candid and transparent. Share your honest thoughts, opinions, and experiences, even if it feels a bit vulnerable to do so.

• **LITERACY MOMENT** – If at any time someone says something that you would like clarified or do not understand—an acronym, piece of data, or anecdote—that anyone in the conversation is welcomed to ask for a literacy moment, or a brief clarifying explanation.

• **ASSUME GOOD INTENT** – It's likely that people will have different opinions or interpretations of the issues we discuss. For the sake of this discussion, listen with an open mind and heart, and be generous with how you hear things. If a statement troubles you, then start from the assumption that we are unified and collegial. We do not shame or blame ourselves or others.

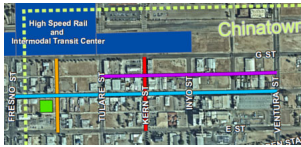
Project Description

Phase 1

- ▶ Streetlights on F Street from Fresno Street to Ventura Street
- ▶ Tree Planting on F Street from Fresno Street to Mariposa Street
- ▶ Green Alley improvements in China Alley between Kern Street and Inyo Street

Phase 2

- ▶ F Street, Kern Street, and Mariposa Street
 - ▶ Street Trees
 - ▶ Street Lighting Improvements
 - ▶ Sidewalk and curb ramp reconstruction
- ▶ Remainder of Green Alley improvements in China Alley from Tulare Street to Ventura Avenue



Current Status

- ▶ Subrecipient Agreement approved by City Council and executed July 25, 2019
- ▶ Request for Qualifications for design consultant published September 27, 2019
- ▶ Tentatively selected design consultant - Dewalt Corporation

- ▶ City Council to approve Agreement February 2020
- ▶ Initial Community engagement May 2020
- ▶ Phase 1 Construction Spring 2021
- ▶ Phase 2 Construction Spring 2023

Project Description

- ▶ Connects to Future High Speed Rail station. (Proposed location S/O Fresno St. between G St. and H St.)
- ▶ Renovations to include:
 - ▶ Tree planting
 - ▶ Permeable paving
 - ▶ Rainwater capture system
 - ▶ Modification of stage and open area
 - ▶ Canopy/Shade structure
 - ▶ Relocation of "Acero Picado"



Current Status

- ▶ Master Agreement
- ▶ Sub-Recipient Agreement totaling \$3,859,000 approved by Council.
- ▶ Request for Qualifications (RFQ) posted for design services.
- ▶ Firms submitting a Statement of Qualifications (SOQ) in response to the RFQ were:
 - ▶ Wallace, Roberts & Todd (WRT) and
 - ▶ Groundworks Office
- ▶ SOQ's reviewed and both firms interviewed. WRT has been tentatively selected as the most qualified firm pending fee negotiation.

- ▶ Execution of Consultant Agreement (January 2020)
- ▶ First Community Engagement Event (May 2020, Projected)
- ▶ Design Complete (March 2021, Tentative)
- ▶ Construction Award (August 2021, Tentative)
- ▶ Construction Completion (April 2022, Tentative)

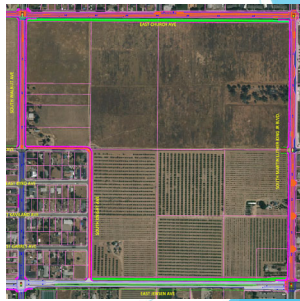

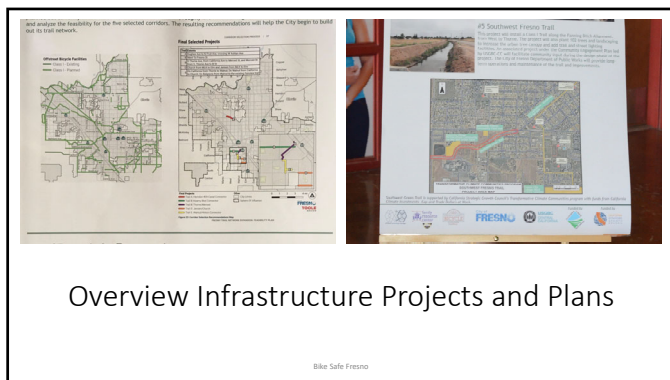

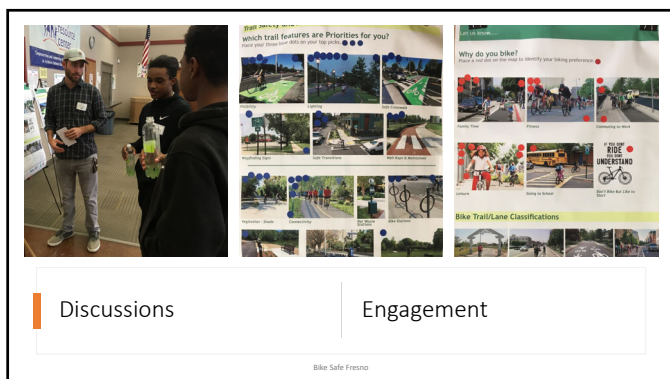
